## **Weatherstock Photo DVD End-User License Agreements**

SAVE THESE DOCUMENTS

Terminology:

The terms "Weatherstock Photo CD," "CD" or "DVD." shall refer collectively, and apply to the same computer disc, as sent to the Client.

1: The following is a legal agreement between you (the "Client") and Weatherstock Inc. PLEASE READ THIS LICENSE CAREFULLY. Upon placing your order and/or placing the CD in your computer, and/or by your use of any Image, you agree the CD is considered purchased and used, and you agree to be bound by all terms in this Agreement.

The price of your CD includes the following rights and restrictions. You do not have to notify Weatherstock of any usage, nor pay any additional reproduction fees, as long as your specific use is legally granted within this Agreement.

2: The word "Image(s)" shall refer to all photographic Images, original, modified, or any part of any Image, contained on the Weatherstock Photo-CD hereafter called the "CD."

3: The Images and the CD are Copyrighted. All rights are owned by Warren Faidley, the noted credit source or Weatherstock. All rights not specifically granted to you by this Agreement are reserved. Your right to use an Image is subject to the restrictions set fourth in this Agreement. No use or rights granted what so ever until full (non-refundable) payment is received by Weatherstock for this CD.

4: By this Agreement, Weatherstock grants to you a personal, non-exclusive, non-transferable right to use the Images from the CD in the following, and only the following ways: (Subject to other restrictions herein).

(A) Print Uses: Advertising, editorials, educational, catalogs, brochures, reports, flyers, product packaging, pop displays, book covers, textbooks, calendars, magazines, in house publications, manuals, pamphlets, newsletters, trade books, encyclopedias, trade show prints, transit displays, billboards and announcements. Promotional printing and products (as long as such items are not re-sold. See No. 6).

(B) Other Than Print Uses: web sites, multi-media, broadcast video, video displays, video/film productions, film strips, television, cable TV, and CD ROMs. Computer, web site and CD uses are granted only if the Image resolution is no greater than 72 dpi. All uses of Images must be incorporated in such a manner so they are clearly not intended to be downloaded or copied.

(C) Licensing rights for the commercial license include all educational and personal uses granted under those separate agreements.

### **Restrictions:**

5: "Non-transferable," as used in Paragraph 4, means that the work you produce using an Image must be for your own use, or for the use of your direct employer, customer or client, who must be the end-user of your work. You may not sell, rent, loan, give, sub license, or otherwise transfer to anyone (including sub-companies and clients) either the CD or an Image, or the right to use the

CD or an Image (except insofar as an Image has been incorporated by you into one of the permitted uses as noted in Paragraph 3 of this Agreement), and nothing you produce shall grant or purport to grant any third party a right to use or duplicate an Image.

6: Images may not be reproduced for re-sale as photographic prints, screen savers, clothing, posters, postcards, artwork or any other reproduction, printing or computer method where the purpose is to sell the Image as a product. (Please contact Weatherstock to extend such rights. In most cases we will grant such extended rights at little or no extra charge). Images may not be re-sold as "stock" Images." The Client may not devise any "loophole" or other method to circumvent the use restrictions herein. Any breach of these specific terms, are penalized under no. 9.

7: You agree to take all necessary reasonable steps to prevent third parties from copying or distributing the Images.

8: The CD and pictures may not be used in any multi-user network, time share, library, file, service bureau or any system where it can be used by more than one person at a time. The Client may not post or otherwise offer the CD or any picture as a raw download (not contained in the body of an actual, legitimate use intended for viewing only), or as "free" or "raw" download to third parties.

9: Defamatory or otherwise unlawful use of any Image is prohibited. Images may not be used for any inflammatory or defamatory purpose, including editorials or statements against Weatherstock, it's agents, sponsors, assigns, heirs, representatives or Warren Faidley. In the event of any defamatory or otherwise illegal use of any Image, the Client agrees to pay a fee of 500 times our normal rates in addition to any legal actions. Clients who use a CD for a purpose not granted under the specific license, or breach of any term(s) herein, shall be responsible for the full payment of \$499.00 plus a \$5,000.00 service fee, in addition to any funds awarded to Weatherstock by any court or judgment. In addition, any abuse or misuse of any Image(s) may be deemed as a copyright, civil or criminal copyright violation since the release of Copyright use is contingent upon the Client's honoring of terms herein.

10: For Client protection and the protection of our copyrights, the following credit line must be used on printed materials or for Internet uses: ©Warren Faidley - Weatherstock.com. For Internet uses, the picture should serve as an active html address for weatherstock.com when clicked and a copyright notice must be maintained on the actual Image.

Warranty and refund policy:

11: All CD's are guaranteed against defects in material and workmanship under normal use and condition, for a period of (30) thirty days from purchase.

12: All registration cards (if provided) must be returned within (30) days. (Client failure to return the registration card shall not alter this Agreement in any way).

13: Refund policy: Due to the royalty free nature of this DVD and the instant release terms, all sales are final! Furthermore, the Client agrees not to request a credit card refund, chargeback or credit. In such events, the client agrees to pay a \$150.00 service fee. Any use of the CD requires full payment. Refunds initiated by the Client and not granted by Weatherstock, do not exempt the Client from US Copyright violations since any use (as noted in no 1) requires a non-refunded payment. In any event, the Client agrees to execute and immediately return Weatherstock's non-use of DVD statement if a DVD is returned and refunded for any reason what so ever.

## **Liability**

14: You agree to indemnify and hold Weatherstock harmless against any damages or liability of any kind arising from any use of an Image other than the uses specifically permitted by this Agreement.

15: Neither Weatherstock nor any of its directors, employees, owners, partners, agents or licensors shall be liable for any damages, whether direct, indirect, consequential or incidental, arising out of the use of, or the inability to use the CD or an Image.

16: Any and all fees or penalties noted herein shall be paid, in full, within 30 days.

17: Should the Client or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, the Client agrees to indemnify and hold Weatherstock harmless for all such fees and costs.

18: I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

19: This Agreement shall be governed by the laws of the State of Arizona (or the State in which Weatherstock is currently legally residing). Venue for any action regarding this Agreement, an Image, or use or attempted use of the CD shall be in Tucson, Arizona (or the City in which Weatherstock is legally residing).
